\$50,000 in AD&D insurance coverage for any bank officer at any TBA member bank injured during a committed or attempted felonious assault.

Periodically, we learn of violence perpetrated against a bank and or its employees. Though rare, these events can be traumatic, and bank employees can be injured ... or worse.

The Texas Bankers Association (TBA) stands with our member banks. In addition to promoting justice for perpetrators of any such crimes through our Robbery Rewards program and other initiatives, TBA is now providing up to \$50,000 in accidental death and dismemberment (AD&D) coverage for any bank officer with any TBA member bank injured during a committed or attempted felonious assault.

WHO IS COVERED?

Any bank officer holding the title of Cashier, Assistant Vice President, Vice President, Senior Vice President, Executive Vice President, Trust Officer, Senior Trust Officer, President, CEO, Chairman, Board Member, and/or specific titles of Chief Operations Officer (COO) Chief Technology/Information Officer (CIO) Chief Financial Officer (CFO), Chief Lending Officer (CLO), Risk Manager, or Branch Manager/President, or General Counsel.

WHAT IS COVERED?

Loss of life, limb, sight or hearing for a bank officer injured during a committed or attempted felonious assault. In addition, the policy will provide \$500 per day while in a hospital after a covered event.

WHAT DOES IT COST?

It costs your bank nothing. TBA is providing this coverage, and the additional peace of mind, as a member benefit.

HOW DOES IT WORK?

If one or more of your bank officers are injured during the course of a committed or attempted felonious assault, contact the Texas Bankers Insurance Agency.
